Stewards spoke to Mr Nathan McKay, the trainer of Tahnee's Flash regarding the greyhound's racing manners approaching the home turn. Mr McKay declined the option to have the greyhound re vetted. Acting under the provisions of GAR 69A(1) Tahnee's Flash was charged with failing to pursue the lure with due commitment. Mr McKay pleaded guilty to the charge, Tahnee's Flash was found guilty and suspended for 28 days at Warrnambool and must perform a Satisfactory Trial in accordance with GAR 69A (2) and pursuant to GAR 72, before any future nomination will be accepted.</p> <p>A post-race sample was taken from Trenzalore - the winner of the event.</p>
