Mr Tolson pleaded guilty to the charge, Chanko Girl was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and GAR 72, before any future nomination will be accepted.</p> <p>Crackerjack Dirt underwent a post-race veterinary examination and was found to have a right back muscle injury. A 14 day stand down period was imposed.</p> <p>Stewards spoke to Trainer Ms M. Brealey regarding the racing manners of Alpine Blaze approaching the winning post. After hearing evidence from Ms Brealey, viewing all the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners.</p>
