Acting under the provisions of GAR 69B(1), Market Legend was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Burkett pleaded guilty to the charge, Market Legend was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B(1) and GAR 72, before any future nomination will be accepted.
