Mr. Johnson pleaded guilty to the charge, Weblec Mist was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Hardcore Vibes underwent a post-race veterinary examination and was found to have a left front leg injury. A 3 day stand down period was imposed. Stewards spoke to trainer, Mr Mario Briganti regarding the greyhound's racing manners on the home turn. Acting under the provisions of GAR 69(1) Hardcore Vibes was charged with marring. Mr. Briganti pleaded guilty to the charge, Hardcore Vibes was found guilty and suspended for 28 days at Sandown and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.
