Trainer Mrs M. Inguanti declined the option to have the greyhound re-vetted. Stewards spoke to Mrs Inguanti regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 69A(1) Inga Cleo was charged with failing to pursue the lure with due commitment. Mrs Inguanti pleaded guilty to the charge, Inga Cleo has been suspended for 28 days at Geelong only and must perform a Satisfactory Trial in accordance with GAR 69A (2) and GAR 72, before any future nomination will be accepted.</p> <p>He's For Us – Proved difficult to box and will be boxed first in future events in accordance with GAR 52.</p> <p>Stewards issued a warning to Trainer Mr. D.
