Mr. Sultana pleaded not guilty to the charge, Hurricane Maggie was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Three Johns underwent a post-race veterinary examination and Mr. Sharp declined to have the greyhound re-vetted. No apparent injury was found. Stewards spoke to Mr. Liam Sharp, the representative of Three Johns regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 69A(1) Three Johns was charged with failing to pursue the lure with due commitment. Mr. Sharp pleaded guilty to the charge, Three Johns was found guilty and suspended for 28 days at Cranbourne and must perform a Satisfactory Trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.
