Gibbons, regarding the greyhound's racing manners on the home turn. Acting under the provisions of GAR 69A(1) Ibbie Bale was charged with failing to pursue the lure with due commitment. Mr Gibbons pleaded guilty to the charge, Ibbie Bale was suspended for 28 days at Geelong only and must perform a Satisfactory Trial in accordance with GAR 69A(2) and GAR 72, before any future nomination will be accepted.
