At the commencement of kennelling, the outside temperature was 33.0 degrees and the kennel temperature was 19.5 degrees. Be Good Goldie and Kira's Choice collided on the home turn checking both greyhounds, Be Good Goldie stumbled and lost ground as a result.</p> <p>Be Good Goldie underwent a post-race veterinary examination and was found to have a left foreleg dew claw injury. A 3 day stand down period was imposed.</p> <p>Kira's Choice underwent a post-race veterinary examination and was re-examined following race 4.
