MEETING COMMENTS

Satisfactory Trial Results - Llewys Lad trialled over 440m from box 8, weight 28.5, the greyhound was placed 2nd in a field of 4. The time of the trial was 25.36, the greyhound was beaten by a margin of 3.75 lengths. Llewys Lad was Cleared.

Stewards today conducted an inquiry into the running of Race 10 at Sale on 13/07/2014. Stewards heard evidence over the phone from Mr. Brayden Jinks (Steward In Charge of the meeting on 13/07/2014). Stewards also heard evidence from Mr. T. Proctor the trainer of Fairy's Fly and Mrs. B. Proctor. After viewing the official race footage, in particular an incident that occurred on the home turn, acting under GAR 69(1) stewards charged Fairy's Fly with marring and suspended the greyhound for 3 months (all tracks) and directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(b), before any future nomination will be accepted.
