### Race 1

After hearing evidence from Mrs. Turner, viewing all the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners.

Stewards spoke to trainer, Mr Raymond Brewer regarding the greyhounds racing manners in the home straight. Acting under the provisions of GAR 69B (1), Jessie's Brew was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Brewer pleaded guilty to the charge, Jessie's Brew must perform a satisfactory trial in accordance with GAR 69B (1) and GAR 72, before any future nomination will be accepted.

Whiz Out underwent a post-race veterinary examination and was found to have a right monkey muscle injury. A 14 day stand down period was imposed.

Mr. Gatt pleaded not guilty to the charge, Just Gab was found guilty and suspended for 28 days at Ballarat only and must perform a satisfactory trial in accordance with GAR 69A(2) and GAR 72, before any future nomination will be accepted.
