Mr Wickham pleaded guilty to the charge, Reiko Haze was found guilty and suspended for three months at all tracks and must perform a Satisfactory Trial in accordance with GAR 69A(2) and GAR 72. before any future nomination will be accepted.

Zipping Winslet underwent a post–race veterinary examination and was re–examined following race 11. Zipping Winslet was found to have a left foreleg wrist injury. A seven day stand down period was imposed. Stewards spoke to Mr Jason Wickham, the representative of Zipping Winslet regarding its performance over the concluding stages. After hearing evidence from Mr Wickham, viewing all the available race footage and acting on their observations, Stewards deemed the performance unsatisfactory, acting in accordance with GAR 71 Zipping Winslet must perform a Satisfactory Trial pursuant to GAR 72, before any future nomination will be accepted.
