Stewards spoke to Mr Trevor Whitford, trainer regarding the greyhounds racing manners on the home turn. Acting under the provisions of GAR 69B (1), Lead the Way was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Trevor Whitford pleaded not guilty to the charge, Lead the Way was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.
