Stewards reconvened an inquiry today with Mr Craig Burns after he left "Tinker Blaine" in the kennels following the meeting at Warrnambool on 28 March, 2022. After taking into consideration all the evidence before them and a submission from Mr Burns, Stewards charged Mr Burns pursuant to GAR86(o) with negligence for leaving the course without "Tinker Blaine" at Warrnambool on 28 March, 2022 and fined him the sum of \$250 to be wholly suspended for 12 months pending no further conviction under GAR86(o)
