Acting under the provisions of GAR 69A(1) Dr. Matrix was charged with failing to pursue the lure with due commitment. Mr. Quinn pleaded guilty to the charge, and Dr. Matrix suspended for 28 days at Geelong and must perform a Satisfactory Trial in accordance with GAR 69A(2) and GAR 72, before any future nomination will be accepted.</p> <p>Screaming Izzy - quick to begin.
