Race 6 GREYHOUND CLUBS VICTORIA 8:22 pm 440m Grade 5 Agronomous– Late scratching at 8.33am when trainer Mr. Justin Bowman reported the greyhound to have an illness (GAR 76). A 10 day stand down period was imposed. Stewards will require a veterinary certificate pursuant to GAR 19(3)(v) before any future nomination will be accepted.

Stewards spoke to Mr. Justin Bowman regarding the time of the withdrawal of Agronomous and reminded Mr. Bowman that prior to the appointed scratching time of an event a greyhound is engaged to compete in, the greyhound must be examined to ensure that it is free of both injury and Illness GAR 76 (1)(a).

Chief Gem – Late scratching at 6:23pm due to the greyhound not being presented (non–arrival) (GAR 86 and LR 39). Due to the circumstances surrounding the non–presentation of Chief Gem, the 28 day stand down period was imposed on the greyhound. Trainer, Kym Russell was fined \$250.
