Mr Solkhon advised that the greyhound's registered Trainer, Mrs Heather Baxter, He's For Us and Sweet Emily (scratched from race 11) are located at the kennel and residential address of Trainers Mr Jeff Britton and Ms Angela Langton for a short period of time. Mr. Solkhon added that Mrs Baxter is responsible for the feeding, training and preparation of the two greyhounds. Mr Solkhon's comments were noted. Trainer Mrs Heather Baxter arrived on course prior to the event. Mrs Baxter confirmed Mr Solkhon's comments.
