After hearing submissions from Mr Colaiacono, viewing the available race footage and having their own observations, Stewards took no further action.</p>

Rainbow Man was very slow to begin (3 lengths).</p> <p>Obsidian To Burn faltered at the 200m mark and lost ground, underwent a post-race veterinary examination and was re-vetted following event 6. Obsidian To Burn was found to have a left wrist injury. A 10 day stand down period was imposed.</p>

After hearing evidence from Mr Schwarz and the Steward at the starting boxes and taking into consideration the circumstances surrounding the incident; Mr Schwarz was reminded of his responsibilities in relation to having proper control of a greyhound at all times, pursuant to GAR 81(1).</p> <p>Bright Black was slow to begin.</p>

A 10 day stand down period was imposed. Stewards spoke to Bradley Chapman regarding Chappy's Cosmog's racing manners soon after the start. Acting under the provisions of GAR 123 Chappy's Cosmog was charged with marring. Mr Chapman pled guilty to the charge, Chappy Cosmog was found guilty and suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
