<b>Race 1</b> TAB - LONG MAY WE PLAY 12:11 pm 525m Maiden	An out of competition sample was taken from Internal Affairs on 2/8/2022 pursuant to GAR 139.  Enticement and Scarlett Express were quick to begin.
<b>Race 2</b> HOME OF TEN GROUP 1'S 12:31 pm 525m Mixed 6/7	Blazer Edition was quick to begin.  Jesse's Shout underwent a post-race veterinary examination and was found to have a left long head triceps muscle injury and a right tensor fascia latae muscle injury. A 7 day stand down period was imposed.  Stewards spoke to Mr. K. Turchett regarding Jesse's Shout's racing manners entering the back straight. Acting under the provisions of GAR 125, Jesse's Shout was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. K. Turchett pled guilty to the charge, Jesse's Shout must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.  A post-race sample was taken from Blazer Edition - winner of the event.
