After hearing submissions from Mr. Coulson, viewing the available race footage and having their own observations, the Stewards issued a warning to connections regarding the greyhound's racing manners in the home straight.</p>

Acting under the provisions of GAR 125, Electra Glide was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. McCullagh pleaded not guilty to the charge, Electra Glide was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
