<b>Race 2</b> GREEN LIGHT ON PODCAST (0-2 W) (225+) 2:20 pm 515m Restricted Win	A pre-race sample was taken from Darnum Diva.  Avery Charm was quick to begin. Rosie's Prince and Rowdy Bourbski were slow to begin.  Rosie's Prince - When questioned regarding the greyhounds performance, which stewards deemed below market expectations (\$1.60 to \$2.60), trainer Steven Bruce White stated that the greyhound has been a slow beginner at its first two starts and he expected the same today. He further stated that the greyhound brushing the running rail approaching the first turn and checking off heels approaching the second turn contributed to the overall performance. Mr White advised his expectations were for the greyhound to make a placing, however did not agree with the opening short price offered and did not support the greyhound. He further added it was his intentions to step the greyhound up in distance believing the greyhound will have a stronger finish and cater towards its slow early speed. A post-race veterinary examination revealed injuries to the left monkey muscle and left back muscle with a 5 day stand down period issued. A post-race sample was taken.

sadownngreyhounds.com.au/splits 3:42 pm 515m Grade 5	<p>Stewards opened and adjourned an inquiry into an incident in the catching pen.</p> <p>Supplementary Report: 1 September 2022 - Stewards finalised an inquiry into the conduct of licensed person Mr Bart Russo when catching the greyhound Rezzie's Shout after the running of Race 6 at Sandown Park Greyhound Racing Club on Sunday, 14 August 2022. Evidence was taken from Mr Bart Russo, Sandown Park catching pen staff, observations from the Stewards, and CCTV footage of the incident was also viewed. After considering all of the evidence, Mr Russo was issued a charge under GAR 165 (a).</p> <p>Rule: GAR 165 - Conduct detrimental to the interests of greyhound racing. An offence is committed if a person (including an official): (a) commits or omits to do any act or engages in conduct which is in any way detrimental or prejudicial to the interest, welfare, image, control or promotion of greyhound racing;</p> <p>Charge: The particulars of the charge being that at Sandown Park Greyhound Racing Club on Sunday, 14 August 2022, shortly after the running of Race 6, Mr Bart Russo caught the greyhound Rezzie's Shout by the tail, which was detrimental and/or prejudicial to the interests and/or image of greyhound racing.</p> <p>Mr Russo pleaded Guilty to the charge. After considering submissions on penalty, Stewards issued Mr Russo with a fine of \$250. In determining penalty, Stewards took into consideration Mr Russo's antecedents and disciplinary history, his guilty plea, his personal circumstances, both specific and general deterrence, and the need to maintain the welfare and image of greyhound racing. The Stewards take the opportunity to remind all participants that the proper and sensible handling of greyhounds is non-negotiable and best practise principles must be undertaken, at all times.</p>

Jimmy Maker was examined by the on-track veterinarian and found to be not free from injury. Jimmy Maker was not cleared to race. A sample was taken for analysis.</p> <p>Cleo's Neo - An Out Of Competition sample was taken when the greyhound was presented for a club trial.</p> <p>-----</p>
