A 5 day stand down period was imposed. Stewards spoke to Mr. Joe Uglietta regarding Lovely Romeo's racing manners at the 150m mark. Acting under the provisions of GAR 125, Lovely Romeo was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Uglietta pled guilty to the charge, Lovely Romeo was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
