Prince Dior underwent a post-race veterinary examination and was found to have a left monkey muscle injury. A 7 day stand down period was imposed. Stewards spoke to Cooper Hayes regarding Prince Dior's racing manners approaching the home turn. Acting under the provisions of GAR 125, Prince Dior was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Hayes pled guilty to the charge, Prince Dior was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

Acting under the provisions of GAR 42, Aston Laurent is prohibited from competing in an event until such time as both a veterinary clearance is provided to the satisfaction of Stewards and a satisfactory trial is completed, pursuant to GAR 132. Further, under the provisions of GAR 42 (3) Aston Laurent, is suspended from racing for 28 days at all tracks.
