Stewards noted that Fernando Bubbles was currently being monitored after failing to enter the catching pen at Ballarat on the 26 September, 2022. Acting in accordance with GAR 129 and being mindful of the safety of Fernando Bubbles, other greyhounds in the race and staff that triage these types of incidents, the Stewards were not satisfied with the performance and placed Fernando Bubbles on a satisfactory trial under GAR 129, and in accordance with GAR 132, with the condition that Fernando Bubbles needs to run past the return gate in order to pass the trial.
