Ms Boots pleaded guilty to the charge, My Name's Lyn was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Coconut Santiago underwent a post-race veterinary examination due to concerns about its racing manners approaching the home turn – no apparent injury was reported. Stewards spoke to Mr Peter Gabriel regarding the racing manners of Coconut Santiago on the home turn. After hearing evidence from Mr Gabriel, viewing the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners on the home turn.</p> <p>Hydro Glide underwent a post-race veterinary examination due to concerns about its racing manners approaching the home turn – no apparent injury was reported. Stewards spoke to Mr Ronald McCullagh regarding the racing manners of Hydro Glide approaching the home turn. After hearing evidence from Mr McCullagh, viewing the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners approaching the home turn.</p>
