A 28 day stand down period was imposed.

Stewards spoke to Mr Kenneth Howat regarding Your Embrace's racing manners at the 150m mark. Acting under the provisions of GAR 123 Your Embrace was charged with marring. Mr Howat pled guilty to the charge, Your Embrace was found guilty and suspended for 28 days at all tracks and must perform a Satisfactory Trial/s in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
