RAY DREW MEMORIAL GDR 7:34 pm 650m Special Event My Catalina – Late scratching at 3:49 pm due to non–arrival (GAR 86 and LR 39). A 28 day stand down period was imposed. Trainer, Mr Arthur Garrat informed Stewards that he had a vehicle breakdown on–route to the track. Stewards advised Mr Garrat that evidence of the breakdown will need to be submitted, to the satisfaction of Stewards, within 72 hours of the occurrence that caused the non–arrival.
