At the commencement of kennelling, the outside temperature was 31.8kg degrees and the kennel temperature was 17.4kg degrees. The Stewards continually monitored the temperature at the venue as per the GRV Hot Weather Policy.</p> <p>During kennelling Stewards conducted a carpark check on all trainers' vehicles engaged in today's meeting. Stewards were satisfied that all transport had adhered to the GRV Hot Weather Policy and the GRV Transportation of Greyhounds Policy.</p> <p>Woodleigh Bluey – Late scratching at 5.10pm due to weight variation (GAR 101). A 10 day stand down period was imposed. Trainer, Mr Gregory Graham was fined \$100.</p> <p>Talent Scout was quick to begin. My Shout Boys was slow to begin.</p> <p>Mega Banjo Boy was galloped on turning off the back straight, tailed off, underwent a post-race veterinary examination and was found to have a spike wound on the left hind and physical exhaustion. <p><b>Race 2</b> KHANS HOSPITALITY SERVICES 6:11 pm 400m Maiden</p>	<p>Jack Hook and Feel Like Flying were quick to begin.</p> <p>Norse Queen fell after the finishing post and underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>Atomic Jax fell after the finishing post, underwent a post-race veterinary examination and was found to have a laceration on the left hind metatarsal region. A 14 day stand down period was imposed.</p> <p>Move Away visibly eased approaching the winning post, underwent a post-race veterinary examination and was found to have right hock sprain. A 7 day stand down period was imposed. Stewards spoke to kennel representative Mark Johnson regarding Move Away's racing manners approaching the winning post. Acting under the provisions of GAR 125, Move Away was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Johnson pled guilty to the charge. Move Away must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Stewards spoke to Mr. Brandon Mackie regarding the racing manners of Feel Like Flying in the home straight. After hearing submissions from Mr. Mackie, viewing the available race footage, and having their own observations, Stewards took no further action.</p> <p>A post-race sample was taken from Jack Hook - the winner of the event.</p>
