Acting under the provisions of GAR 124 Mr. Blitz was charged with failing to pursue the lure with due commitment. Mr Green pled not guilty to the charge, Mr. Blitz was found guilty and suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Ms McMillan pled guilty to the charge and was fined \$250.
