After hearing submissions from Mr. Bunchusri, viewing the available race footage and acting on their observations, Stewards deemed the performance of Lala Ultra Fast unsatisfactory. Lala Ultra Fast must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p>
