At inquiry, the Stewards issued a charge under GAR 86 to Trainer, Mr. C. Treherne, for failing to present the correct greyhound to the Stewards for this event. Mr. Treherne pled guilty to the charge, and was fined \$250. The 28-day stand-down on Holding Pattern was revoked.</p> <p>Maranello was quick to begin.</p> <p>Stewards spoke to Representative - Mr. Graham Julian of Quest Of Fame after the greyhound underwent a post-race veterinary examination and was found to have a seizure following the finish of the event. Acting under the provisions of GAR 42, Quest For Fame is prohibited from competing in an event until such time as both a veterinary clearance is provided to the satisfaction of Stewards and a satisfactory trial is completed, pursuant to GAR 132. Further, under the provisions of GAR 42 (3), Quest For Fame is suspended from racing for 28 days at all tracks.</p> |
