Mr. Dailly pleaded guilty to the charge, Todling Bale was found guilty and suspended for 28 days at Ballarat only and must perform a Satisfactory Trial in accordance with GAR 127 and pursuant to GAR 132, before any future nomination will be accepted.</p>
