<b>Race 1</b> SPORTSBET – SAME RACE MULTI 11:39 am 525m Maiden	<p>The closing time of kennelling was altered in accordance with GAR 86, due to the late arrival of several trainers who experienced significant traffic delays on–route to the track. The kennels closed at 11:21am.</p> <p>A sample upon arrival was unable to be taken from Starburst Candy, a pre–race sample was subsequently taken.</p> <p>Vale Orchard was slow to begin.</p> <p>Vale Orchard (lost ground entering the back straight), underwent a post–race veterinary examination and was found to have a right hip injury. A 10 day stand down period was imposed.</p> <p>A post–race sample was taken from Strawberry Sweet – the winner of the event.</p>

<b>Race 2</b> KCR PET TRANSPORT 11:54 am 525m Grade 5	<p>Crown Ella was quick to begin.</p> <p>Wish You Well (turned its head outwards on the home turn), underwent a post–race veterinary examination and was found to have no apparent injury. Mr Howat declined the option to have the greyhound re–vetted.</p> <p>Stewards spoke to Mr Howat regarding Wish You Well's racing manners on the home turn. Acting under the provisions of GAR 124 Wish You Well was charged with failing to pursue the lure with due commitment. Mr Howat pled guilty to the charge, Wish You Well was found guilty and suspended for 28 days at Meadows and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post–race sample was taken from Rare Sapphire – the winner of the event.</p>

<b>Race 3</b> COOKES ELECTRICAL AND AIR CONDITIONING 12:15 pm 525m Mixed 4/5	<p>Dookie Devil – Late scratching at 12:07pm on the advice of the On–Track Veterinarian (GAR 92) due to a papilloma to the left front paw. A 14 day stand down period was imposed.</p> <p>Acclaimed (fell on the first turn), underwent a post–race veterinary examination and was found to have a left triangle injury. A 7 day stand down period was imposed.</p> <p>A post–race sample was taken from Mckeen Bale – the winner of the event.</p>

<b>Race 4</b> HOUDINI BOY @ STUD GDR 12:31 pm 730m Special Event	<p>Frist Picked was quick to begin.</p> <p>Clips lost ground over the concluding stages, underwent a post–race veterinary examination – no apparent injury was reported. When questioned regarding the greyhounds performance, kennel representative Mr. Dale Chapman stated that the greyhound had only previously won when jumping to the lead and was outclassed by other greyhounds in todays field. He further added the greyhound was expected to be relatively competitive. In accordance with GAR 122, the Stewards requested Mr Chapman to report as soon as practicable anything that may have affected the running of Clips in the event, which was not noted by Stewards during or immediately after the event. After hearing submissions from Mr Chapman, viewing the available race footage and having their own observations, the Stewards issued a warning to connections regarding the greyhound's racing manners in the event.</p> <p>A post–race sample was taken from Boom Lateral – the winner of the event.</p>

<b>Race 10</b> THE GREAT CHASE SEMI FINAL 6 2:37 pm 525m S/E Heat	<p>Cruising Through – Late scratching at 7:38am when Ms D.Johnston reported the greyhound to have Diarrhoea (GAR 76). A 10 day stand down period was imposed. Stewards will require a veterinary certificate pursuant to GAR 19(3)(w) before any future nominations will be accepted.</p> <p>Rock Me Rocco and Blazin' Master were slow to begin.</p> <p>Blazin' Master (marred the running of Elite Alex), underwent a post–race veterinary examination – no apparent injury was reported.</p> <p>Stewards spoke to Representative Ms A.Langton regarding Blazin' Master's racing manners in the home straight. Acting under the provisions of GAR 123 Blazin' Master was charged with marring. Ms Langton pled guilty to the charge, Blazin' Master was found guilty and suspended for 28 days at today's track and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post–race sample was taken from Elite Alex – the winner of the event.</p>
