These four greyhounds are littermates and shared between the two kennels. Mr Howat, Mr Lavelle and Mr Brincat all explained that the greyhounds have been trialling at Geelong over the track and distance regularly and most recently on Saturday 3/12/2022. The performances of the greyhounds last Saturday were satisfactory, and the connections were at a loss to explain today's performances.
