Acting under the provisions of GAR 123, Zipping Dixie was charged with marring. Mr. Adams pleaded guilty to the charge, Zipping Dixie was suspended for 28 days at all tracks and must perform a satisfactory trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.<br><br>Counterpunch (marred Krystal Bale on the home turn), underwent a post-race veterinary examination and was found to have an injury to the right stopper, left monkey muscle and a spike wound to the left-hind calf. A 10 day stand down period was imposed. Stewards spoke to Trainer Ms Lyn Smith regarding the greyhound's racing manners on the home turn. Acting under the provisions of GAR 123, Counterpunch was charged with marring. Ms Smith pleaded guilty to the charge, Counterpunch was suspended for 28 days at Sandown only and must perform a satisfactory trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.<br><br>Cardigan Girl (fell on the first turn), underwent a post-race veterinary examination and was found to have a fracture to the right hind tibia and fibula. A 90 day stand down period was imposed.<br><br>Noah Charles (marred by Zipping Dixie), underwent a post-race veterinary examination and was found to have a right monkey injury.
