Stewards spoke to Mr Mason Koffman, the representative of Minty Freshman regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 124 Minty Freshman was charged with failing to pursue the lure with due commitment. Mr Koffman pleaded guilty to the charge, Minty Freshman was found guilty and suspended for 28 days at Warrnambool and must perform a Satisfactory Trial/s in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>

The Stewards hold concerns that this poses an unnecessary safety issue for Curly Fries, for other greyhounds in the race and staff that triage these types of incidents. After considering submissions from Mr Byrne, Curly Fries has been placed on a conditional satisfactory trial in accordance with GAR 129.</p>
