Race 1 BRIDGES ON ARGYLE TRARALGON 6:56 pm 395m Maiden	<p>Madalia Snoopy and Ohana Steamy were slow to begin.</p> <p>It was noted that the muzzle of Tommy Tornado became dislodged during the running of the event.</p>
Race 2 HOOKED ON SCOTCH @ STUD 7:12 pm 395m Grade 7	<p>Ohana Brockie was slow to begin. Nicola Rose went up with the lids and was very slow to begin (3 Lengths).</p> <p>Mac's Damage galloped on Round Here at the 150m mark and underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Round Here was galloped on by Mac's Damage and subsequently fell, underwent a post-race veterinary examination and was found to have a right fore biceps brachii injury. A 28 day stand down period was imposed.</p> <p>Ohana Brockie marred Gero Lads approaching the winning post, underwent a post-race veterinary examination and was found to have a shin soreness and a left back muscle injury. A 7 day stand down period was imposed. Stewards spoke to Mr Raymond Floyd regarding Ohana Brockie's racing manners approaching the winning post. Acting under the provisions of GAR 123 Ohana Brockie was charged with marring. Mr Floyd reserved his right to enter a plea. Ohana Brockie was found guilty and suspended for 28 days at Traralgon and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race sample was taken from Cool Summer – the winner of the event.</p>

Race 7 SPORTSBET GREEN TICKS 9:02 pm 395m Mixed 4/5	<p>Gold Skulltula – New declared weight of 32.9kg, last raced at 31.5kg.</p> <p>Gold Skulltula faltered approaching the first turn, underwent a post-race veterinary examination and was found to have a right back muscle injury. A 21 day stand down period was imposed.</p> <p>A post-race sample was taken from Harley Ryder - the winner of the event.</p> <p>Following the running of this event, Stewards inspected the track in the back straight and deemed it satisfactory for racing.</p>
