A 14 day stand down period was imposed. Stewards spoke to Mr Zachary Gray, the representative of Orbital Bale regarding the greyhound's racing manners on the first turn. Acting under the provisions of GAR 123 Orbital Bale was charged with marring. Mr Gray pleaded guilty to the charge, Orbital Bale was found guilty and suspended for 28 days at Ballarat and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
