Maverick Marlion (lost ground in the home straight) , underwent a post-race veterinary examination and was found to have a right thigh muscle injury. A 10 day stand down period was imposed.

Race 2 RACERS FUNCTION CENTRE 12:28 pm 385m Tier 3 - Maiden	A pre-race sample was taken from Stickle Back. Susie's Legacy, Got A Deal and Posh Yung were slow to begin. Posh Yung (checked on the first turn), underwent a post-race veterinary examination – no apparent injury was reported. A post-race sample was taken from Got A Deal – the winner of the event.

Race 3 CKH PAINTING (1-2 WINS) 12:48 pm 385m Tier 3 - Restricted Win	Our Boy Billy – Late scratching at 11:20am on the advice of the On-Track Veterinarian (GAR 92) due to an elevated temperature. A 5 day stand down period was imposed. Alligator Black and Janie Cabang were slow to begin. Jocularly underwent a post-race veterinary examination at the trainer's request and was found to have a right flexor tendon injury and a right abraded carpal pad. A 14 day stand down period was imposed.

Race 4 RICH RIVER GOLF CLUB 1:05 pm 385m Tier 3 - Grade 6	A pre-race sample was taken from Golden Coast. Golden Coast was quick to begin. Wonder Jab and Northern Regie were slow to begin. Silky Filo (checked approaching the home turn), underwent a post-race veterinary examination and was found to have a right triangle muscle injury. A 5 day stand down period was imposed.

Race 5 BYERS ELECTRICAL (1-2 WINS) 1:22 pm 450m Tier 3 - Restricted Win	A pre-race sample was taken from Queen Charisma. Acting in accordance with the GRV Lightning and Thunderstorm Safety Procedure, racing was suspended at 1:33pm due to continuous lightning strikes within the designated safety zone around the Shepparton venue. Due to the ongoing and continuous Lightning and Thunderstorm activity in the vicinity of the track and some damage to the racing surface caused by significant rainfall, the Stewards abandoned the race meeting at 2.20pm, pursuant to GAR 110 (4). All bets on greyhounds in the abandoned races (6 - 10) are to be refunded. The weights recorded for the greyhounds in the abandoned races (6 - 10) are void and do not count for the purposes of the weight rule at the greyhounds' next start. Prizemoney for the abandoned races will be split evenly between the eligible greyhounds, at the time of abandonment.
