Mr B Keel pled guilty to the charge, Kanji Seattle was found guilty and suspended for 28 days at Ballarat and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted. Stewards also spoke to kennel representative Mr. B Keel, regarding the greyhound pulling up prior to the return gate and failing to enter the catching pen. After viewing the available race footage and acting on their observations, a warning was issued under GAR 129.

Stewards spoke to kennel representative Mr B Keel regarding Kanji Rome's racing manners in the home straight. Acting under the provisions of GAR 124 Kanji Rome was charged with failing to pursue the lure with due commitment.
