After hearing submissions from Ms. Pirani, viewing the available race footage, and acting on their observations, Stewards deemed the performance of Our Solitaire unsatisfactory. Our Solitaire must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.

Lindenow Lass marred Pacific Prayer approaching the winning post, underwent a post-race veterinary examination and was found to have a right wrist injury. A 10 day stand down period was imposed. Stewards spoke to representative Mr. John Musselwhite regarding Lindenow Lass' racing manners approaching the winning post. Acting under the provisions of GAR 123, Lindenow Lass was charged with marring. Mr. Musselwhite pled guilty to the charge and Lindenow Lass was suspended for 28 days at Warragul and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
