A 28 day stand down period was imposed.</p> <p>Tinker Dan lost ground in the home straight, underwent a post-race veterinary examination and was re-examined following race 9. Tinker Dan was found to have abrasions and contusion. A 7 day stand down period was imposed. Stewards spoke to Mr. M. Giddings regarding the racing manners of Tinker Dan in the home straight. After hearing submissions from Mr. Giddings, viewing the available race footage and having their own observations, the Stewards issued a warning to connections regarding the greyhound's racing manners in the home straight.</p>
