Scotch And Coke was quick to begin

Scotch And Coke visibly eased and turned its head outwards turning into the front straight and marred Learned Lesson in the home straight. Underwent a post-race veterinary examination and was found to have a left-fore monkey muscle injury. A 7 day stand down period was imposed. Stewards spoke to trainer Mr. Adrian Nuttall regarding Scotch And Coke's racing manners. Under the provisions of GAR 126, the offence of marring must be preferred by the Stewards. Therefore, acting under the provisions of GAR 123, Scotch And Coke was charged with marring. Mr. Nuttall pleaded guilty to the charge and Scotch And Coke was suspended for 28 days at The Meadows and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Penny's Princess fell in the catching pen, underwent a post-race veterinary examination and was found to have a left-fore monkey muscle injury. A 5 day stand down period was imposed.

Nymph marred Hurricane Hazel approaching the winning post, underwent a post-race veterinary examination and was found to have a right-hind triangle muscle injury. A 14 day stand down period was imposed. Stewards spoke to kennel representative Mr. Paul Hammerstein regarding Nymph's racing manners. Acting under the provisions of GAR 123, Nymph was charged with marring. Mr. Hammerstein pleaded not guilty to the charge, Nymph was found guilty and suspended for three months at all tracks and must perform two Satisfactory Trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Life's Good was quick to begin.

Life's Good tired and lost ground turning off the back straight and continued to lose ground to the winning post. Underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to trainer Ms Rebekah Dudley regarding Life's Good's performance in the event. Ms Dudley advised Stewards that the greyhound is continuing to regain fitness after a previous injury and may be better suited to Tier 3 company. Ms Dudley advised Stewards that she may continue to race the greyhound over the same distance. Stewards advised Ms Dudley that they will take no further action today but should Life's Good prove to be uncompetitive over the same distance in future, the greyhound may be placed on a Satisfactory Trial.

Lochinvar Jazz was severely checked turning into the back straight, underwent a post-race veterinary examination and was found to have a left-fore chest injury. A 7 day stand down period was imposed.

Stewards noted that the muzzle of Lamont Bale became wedged in the greyhound's mouth during the running of the event.
