Quota Bale was very slow to begin (3 lengths)</p> <p>Deedee's Hope collided with Vitality Blast approaching the first turn and subsequently fell, underwent a post-race veterinary examination and was found to have abrasion around the muzzle area. A 0 day stand down period was imposed.</p> <p>Vitality Blast was severely checked approaching the first turn, underwent a post-race veterinary examination – no apparent injury was reported.</p>
<p><b>Race 2</b> VIATEK HT1 7:02 pm 400m Mixed 6/7 Heat</p>	<p>Whizbang Jack was quick to begin. Spirit World and Chase Me Wal were slow to begin.</p> <p>A post-race sample was taken from Whizbang Jack– the winner of the event.</p>
<p><b>Race 3</b> PAUA KENNELS HT2 7:19 pm 400m Mixed 6/7 Heat</p>	<p>Lilly's Stripey and His Genius Hands were slow to begin.</p> <p>Our Lulu faltered in the first turn and subsequently tailed off, underwent a post-race veterinary examination and was found to have a left hindleg hamstring injury. A 60 day stand down period was imposed.</p> <p>A post-race sample was taken from Mi Amigo Tequila– the winner of the event.</p>
<p><b>Race 4</b> FIND US ON FACEBOOK 7:39 pm 460m Mixed 6/7</p>	<p>Cindy's Charm and Meteor Monelli collided approaching the first turn and both greyhounds subsequently fell. Both of fallen greyhounds then proceeded to run back in the opposite direction at pace, towards the lure and remainder of the field. In the interests of the safety and welfare of all greyhounds, the lure was pulled up slowly prior to the winning post, with the race not being completed. As such, pursuant to GAR 110, the event was declared a 'No Race'. All bets are refunded. The weights recorded for the greyhounds are void and do not count for the purposes of the weight rule at the greyhounds' next start. In accordance with GAR 111, the event was then abandoned, with prizemoney to be split evenly between the greyhounds which competed.</p> <p>Cindy's Charm fell approaching the first turn, underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Meteor Minelli fell approaching the first turn, underwent a post-race veterinary examination and was found to have a right foreleg carpal sprain injury. A 5 day stand down period was imposed.</p> <p>All remaining greyhounds were vetted post-race - no apparent injuries were reported</p>
