A 5 day stand down period was imposed. Stewards spoke to trainer Mr. Adrian Nuttall regarding Catch The Outlaw's racing manners approaching winning post. Acting under the provisions of GAR 125, Catch The Outlaw was charged with failing to pursue the lure with due commitment (by reason of injury).
