A 7 day stand down period was imposed.</p> <p>Stewards spoke to Representative Ms C.Hooke regarding the racing manners of Missin' The Bug at box rise. After hearing submissions from Ms. Hooke, viewing the available race footage and having their own observations, the Stewards issued a warning to connections regarding the greyhound's racing manners at box rise.</p> <p>Handler Mr Steven McDonnell failed to appear at the kennels by the appointed time to retrieve and prepare Whiskey Cavalier for racing. A warning was issued pursuant to GAR 97(2).</p>

Overdrawn was found to have left quadriceps and a left pencil muscle injury. A 7 day stand down period was imposed.</p> <p>Stewards spoke to Trainer Ms D.Knight regarding Overdrawn's racing manners entering the home straight. Acting under the provisions of GAR 125, Overdrawn was charged with failing to pursue the lure with due commitment (by reason of injury). Ms Knight pleaded not guilty to the charge, Overdrawn was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
