After hearing submissions from Ms Dudley, viewing the available race footage and having their own observations, Stewards took no further action.</p> <p>Following the event Nourish displayed mild signs of Post Exercise Distress Syndrome (PEDS). As a result, the greyhound underwent a post-race veterinary examination and was found to be displaying clinical signs of Ataxia/Hypermotria. A 7 day stand down penalty was imposed.</p> <p>Stewards spoke to Mr Brent Merton, the trainer of Nourish and advised him that the greyhound would be closely monitored in future starts.</p> <p>A post-race sample was taken from Abysmal - the winner of the event.</p>
