A 7 day stand down period was imposed. Stewards spoke to trainer Mr. Leslie Kenyon regarding Quest For Luck's racing manners approaching the winning post. Acting under the provisions of GAR 125, Quest For Luck was charged with failing to pursue the lure with due commitment (by reason of injury). At a subsequent inquiry, Stewards issued a charge under GAR 86 to Mr. Neil Jones for failing to present the correct greyhound to the Stewards for this event. Mr. Jones pleaded guilty to the charge and was fined \$250.
