Therefore, and acting in the best interests of racing, the Stewards ordered (for all greyhounds presented post the scales failing) that their last start weight was recorded as today's actual weight and that these weights will be used for the purposes of the weight rule at the greyhounds' next start. GAR 100 Weighing - (1) A Controlling Body or authorised person may make orders in respect of the weight of a greyhound as it thinks fit in the interests of greyhound racing.</p> <p>Ohana Steamy and Royal Silk were quick to begin. Stewards spoke to Gregory Graham regarding Woodleigh Bluey's racing manners on the first turn. Acting under the provisions of GAR 124 Woodleigh Bluey was charged with failing to pursue the lure with due commitment. Gregory Graham pleaded guilty to the charge, Woodleigh Bluey was found guilty and suspended for 28 days at Warragul and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Trapezoid Girl shifted out on the home turn, underwent a post-race veterinary examination and was found to have a left back muscle injury. A 7 day stand down period was imposed. Stewards spoke to Arend Gringhuis regarding the racing manners of Trapezoid Girl on the home turn. After hearing submissions from Arend Gringhuis, viewing the available race footage and having their own observations, the Stewards issued a warning to connections regarding the greyhound's racing manners.</p> <p>Simba's Queen turned its head outwards in the home straight, underwent a post-race veterinary examination – no apparent injury was reported. Stewards spoke to Sean Lithgow regarding Simba's Queen's racing manners in the home straight. Acting under the provisions of GAR 124 Simba's Queen was charged with failing to pursue the lure with due commitment. Sean Lithgow pleaded guilty to the charge, Simba's Queen was found guilty and suspended for 28 days at Warragul and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>There was no head-on vision available in the back straight for this event.</p> |
