A 0 day stand down period was imposed. Stewards spoke to Ms Kerry Minne regarding Indestruct's racing manners in the home straight. Acting under the provisions of GAR 125, Indestruct was charged with failing to pursue the lure with due commitment (by reason of injury). Ms Minne pled not guilty to the charge, Indestruct was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
