Stewards spoke to representative, Ms J.Lyons regarding Conali's racing manners in the home straight. Acting under the provisions of GAR 123, Conali was charged with marring. Ms Lyons pleaded guilty to the charge. Conali was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Mepunga Tilly (marred Pretty With It turning into the home straight), underwent a post–race veterinary examination and was found to have a right deltoid injury. A 14 day stand down period was imposed.

Stewards spoke to representative, Ms J.Lyons regarding Mepunga Tilly's racing manners turning into the home straight. Acting under the provisions of GAR 123, Conali was charged with marring. Ms Lyons pleaded guilty to the charge. Mepunga Tilly was found guilty and suspended for 28 days at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
